

Data Illusion's Terms and Conditions

Acceptance of Terms

You ("Customer") agree following terms and conditions, before buying any of Data Illusion Zumbrunn ("Supplier") products. Please review the following terms and conditions, before downloading any materials from Supplier's Website or buying of Supplier's Software Products.

Notice Specific to Software Available

Any software that is made available to download is the copyrighted work of Supplier. Use of the Software is governed by the terms of the end user license agreement that accompanies or is included with the Software ("License Agreement").

Any reproduction or redistribution of Supplier's software not in accordance with the License Agreement is expressly prohibited by law, and may result in severe civil and criminal penalties. Violators will be prosecuted to the maximum extent possible.

Orders / Pricing

All prices are quoted in US Dollars. Prices listed for Supplier's product are for information only and are not considered as a fixed offer until an order is processed; If Customer needs a fixed offer Customer may contact Supplier to receive a purchase proposal.

Orders can be placed from Supplier's website by registering Customer's contact information to create a customer account or by contacting Supplier. Customer can pay either through credit card, bank wire or checks. If Customer must issue a purchase order Customer may contact Supplier to get all details to raise Customer's purchase order.

Non-Refundable

All orders for downloadable products are final and are not refundable.

Customer has the chance to 'try before purchase' without any time limit.
